1. All applications are due in the Zoning Office by 3:00 p.m. on the application deadline date which is the third Thursday of the previous month.
2. All documents, support materials, and fees must be on file with the Zoning Inspector by the deadline in order to be placed on the next agenda.
3. Applications deemed incomplete by the Zoning Inspector will not be placed on the next agenda.
4. Notification letters and agendas will be sent or emailed to the applicant listed on the application.
5. All applicants must attend their scheduled meeting date in order to be heard.
6. Public hearings requiring advertising will be published per the requirements of the Ohio Revised Code.
